

**NOTICE GIVEN UNDER SECTION 708A(5) OF THE CORPORATIONS ACT**

This notice is given by King River Copper Limited ("Company") under section 708A(5)(e) of the Corporations Act in relation to the issue of 71,000,000 Placement Shares (refer ASX announcement dated 21 September 2017) to sophisticated, professional and other investors who are exempt from the disclosure requirements under Chapter 6D of the Corporations Act.
